

## **TFW Worker 2021 Arrivals**

The following are key considerations and links to help you navigate through requirements of arriving agricultural workers for 2021 while we are still under pandemic rules. **Please ensure you contact your workers well in advance to ensure they are aware of these new procedures.**

### **Prior to Arrival**

Effective January 7, all passengers five years of age or older, are required to test negative for COVID-19 by either a molecular polymerase chain reaction (PCR) or Loop-mediated Isothermal Amplification (LAMP) test before travelling by air from another country to Canada. Certain countries with limited capacity for testing have been provided with an extension to the 72 hours (to 96 hours) or exemptions (Jamaica until Jan 18<sup>th</sup> with test upon arrival at Pearson) but these are only temporary measures. It is therefore crucial to give your workers notice of these new requirements as soon as possible.

### **ArriveCan App**

As of November 21, 2020, all travellers entering Canada, including Temporary Foreign Workers (TFW) will be required to submit contact and quarantine information digitally upon and after entry via the ArriveCAN app or webpage.

**You must use ArriveCAN before you board your flight** to Canada.

**If you're not the traveller**, you can submit travel information on behalf of others who may be unable to use ArriveCAN by:

- [downloading the ArriveCAN app](#) or
- [signing in online](#)

Once you've submitted their information, print the receipt page or take a screenshot. Send it to the traveller to show to the border services officer. The traveller is responsible for ensuring they're compliant with the requirements for entry into Canada. You don't need to be travelling with them.

### **PCR Testing at the Airport**

The Ontario government launched a COVID-19 testing program at Toronto Pearson, starting on January 6, 2021. This pilot program will offer free voluntary tests for international passengers arriving in Canada. Testing will be made available at both Terminal 1 and Terminal 3, administered by Switch Health.

## **On the Farm**

### **COVID Workplace Safety Plan & Templates**

The [Working with farm operators to stop the spread of COVID-19 on farms](#) resource (also known as the Toolkit) is kept up to date by OMAFRA. The resource includes information to support employers as they work to keep workers safe, resources and funding available, and what to do if your farm experiences workers with symptoms, test positive, and in the event of an outbreak.

### **Active Screening**

Daily active screening of all employees (not just TFW) is required. Active screening log templates in Spanish and English are available on the tender fruit website under the grower section <https://www.ontariotenderfruit.ca/growers/index>

## **Federal Funding for 14-day TFW Quarantine**

Applications for the 2021 program year will be accepted until 6:00pm. EST March 31, 2021 or until funding has been fully committed or until otherwise announced by the program. The 2021 program year begins on January 1, 2021 and will provide funding for workers who arrive in Canada on or after January 1, 2021 and up to March 31, 2021, or the expiry or repeal of the Order under the Quarantine Act, whichever comes first.

### **Steps:**

- 1. apply with the expected number of arriving workers**
- 2. successful applicants will receive a contribution agreement that will need to be signed**
- 3. submit claim form**

You may submit more than one claim if you have temporary foreign workers arriving on different dates throughout the season, or you may wait until all of your workers have arrived and submit one claim for all.

You must include the Unique Client Identifier (UCI) for every temporary foreign worker as well as their date of arrival. The UCI is assigned by Immigration, Refugee and Citizenship Canada to each temporary foreign worker and should be available on the worker's work permit.
